General Terms and Conditions

1. Application for, and Allocation of, Space

An intending Exhibitor is invited to select his site from the floor plan and make formal application on the appropriate form. The allocation of space will be effected in the order of receipt of applications and each such application will be confirmed by the Organisers by letter, facsimile or email.

In the event of an Exhibitor giving written notice at any time prior to the Exhibition of their intention not to take possession of the space allocated, or in the event of said Exhibitor failing to take possession of such space by noon on the day prior to the opening of the exhibition, the Organisers may deal with such space as in its absolute discretion thinks fit, without being under any liability to refund or abate any charges paid or due hereunder. Furthermore, in the event of an Exhibitor ceasing to hold the qualifications on the basis of which an allocation of space was made to him, or in the event of the Organisers not being reasonably satisfied of the Exhibitor's intention adequately to occupy the allotted space with approved exhibits, the Organisers may in its absolute discretion deal with such space as it thinks fit without being under any liability to refund or abate any charges paid or due hereunder. The Organisers reserve the right to alter the layout of the Exhibition in any respect and at any time. The Organisers will adjust the cost of the space of anyone or more Exhibitors whose stand area is affected by such an alteration, but will not be liable to make any further payment or compensation and the Exhibitors will not be entitled to withdraw from their contracts.

2. Power

Standard Booth: Exhibitors are given power only for the entitled spotlights as per the package. Additional power for any other electrical application over and above the entitlement should be ordered through the order form in the Exhibitor manual.

Raw Space: Participation fees for Raw space does not include power charges. Exhibitors are required to order and to make the necessary payment for their power requirement as per the order form provided in the Exhibitor Manual.

3. Payment

An initial payment of one third ($\frac{1}{3}$) of the total hiring charge of the contract must be made with the application. A further payment of two thirds ($\frac{2}{3}$) of the total hiring charge is due three months prior to the exhibition. Invoices will be submitted and all payments must be made in Euro. All banking charges, if any, are to be borne by the applicant. Service Tax subject to change and applicable as per the prevailing rate

4. Cancellation

A contracted Exhibitor requesting to cancel participation for any reason shall be liable to the following cancellation charges:

Up to nine months prior to the Exhibition.....	25% of space cost
Between six and nine months prior to the Exhibition	50% of space cost
Between three and six months prior to the Exhibition.....	75% of space cost
Less than three months prior to the Exhibition.....	100% of space cost

All requests for cancellation must be made in writing and dated, this date being that which shall pertain in calculating the charge payable.

5. Limitation of Liability

The Organisers shall not be responsible under any circumstances to any Exhibitor for the acts conduct or omissions of any other Exhibitor or any other persons, whether its servants or otherwise, nor for the consequences of any breach by an Exhibitor of any of these Terms and Conditions. Every article exhibited will be at the sole risk and responsibility of the Exhibitor and the Organisers will not be responsible for loss or damage to, or the safety of, any property or of any injury to an Exhibitor or his servants or agents under any circumstances whatever, whether by reason of fire, water, theft, accident or any other cause including the erection, maintenance or dismantling of stands or otherwise.

Each Exhibitor hereby indemnifies the Organisers and will keep them indemnified against any liability, claim, demand, costs, charges or expenses arising as a result of any act, omission, negligence or thing done, or omitted, by such Exhibitor or any licensee of such Exhibitor or any other person or persons under the direction of the Exhibitor and the Exhibitor will arrange insurance in the joint names of the Exhibitor and the Organisers against all risks for which he is responsible under these Conditions and will, if so required, produce to the Organisers particulars of such insurance policy and evidence of the payment of the premium.

6. Force Majeure

In the event of the Exhibition premises or any part or stand thereof or any facility or service appertaining to the Exhibition being unavailable as a result of fire, flood, tempest or any other cause or as a result of government intervention, strike, lock outs, labour dispute, riot or any other cause or agency over which the Organisers have no control, or should the Organisers decide that owing to any such cause or agency it is necessary or advisable to cancel, postpone or move the Exhibition to another site, the Organisers shall not be liable to indemnify or reimburse the Exhibitor in respect of any damage or loss, direct or indirect arising as a result thereof.

7. Service Manual

A service manual giving information, guidance and direction to Exhibitors, designers and contractors will be issued in good time. All mandatory directions contained therein must be observed except where otherwise agreed by the Organisers in writing.
